1. Information about the Studios

Studio "Biped" (B)
16 rue Geoffroy l'Asnier 75004 Paris (1st floor)

Studios "May B" (MB), "Nelken" (NK), "So Schnell" (SC),
15 rue Geoffroy l'Asnier 75004 Paris (2nd basement)

Studio "Noces" (NC)
20 rue Geoffroy l'Asnier 75004 Paris (Code gateway 7542, backyard ground floor left)

2. Practice Schedule:

3. Insurance

The ADDP declares that it has taken out the necessary insurance to cover the risks associated with the activities developed in its dance studios with Mutuelles du Mans Assurances (MMA).

The ADDP declares that it has informed its members of their interest in taking out a personal insurance policy covering bodily injury to which their sporting practice may be exposed (Article L. 321-4 of the Sports Code).

The Participant declares to have taken out liability insurance for all bodily injury, material or immaterial, consecutive or not, which could be caused to third parties during the time of his/her presence on the site or inside the premises.

The Participant is also required to insure himself, against all risks, all objects belonging to him/her, whatever the conditions of provision.

4. Obligations of the Participant

The Participant agrees to:

- use the studios exclusively for rehearsals / practices / workshops. Any other use of the studios (auditioning, presenting in front of professionals, audio-visual recording, taking photographs, projection of images) will have to be the subject of a preliminary agreement with the **ADDP**. In this context only the members of an association, or the registrants with the **Participant** for rehearsals / practices / workshops, will have access to the premises in accordance with the schedule.
- to be responsible for the proper functioning of his/her activity: the schedule established by mutual agreement must be respected so as not to limit other users of the same studios.
- not to disclose the access code to the studio outside the framework of the company and therefore in any case publish it on a flyer, or on the internet. This code must remain confidential for the proper functioning of the place.
- any additional material will be agreed with the **ADDP**. The nature of the materials, decoration or any other equipment necessary for the rehearsals / practices / workshops brought by the **Participant** must comply with the safety standards in force in the LES (Public Accepted Establishment), including the fire standards: "materials not flammable, fireproof or classified M1".
- to create no disturbance that could interfere with the enjoyment of the studios, knowing that within the site several studio releases are made to different occupants. The noise level of the activities should not disturb the neighborhood (maximum 70db).
- to return the premises for which the **Participant** is responsible in the state in which he/she found them.
- to enforce the health and safety rules in force in the premises at his/her disposal, as well as in the common areas of the site to which he/she could have access. The **Participant** declares to have read and accepted the "**characteristics and general conditions of use**" of the studios:
- to keep the **ADDP** informed of any accidents that may occur during his/her activity in the premises.
- to respect, to enforce under his/her responsibility all the safety instructions. If failing to meet them, the present provision may be terminated without delay if it seems to the **ADDP**, after the breach the regulation has been established. In particular, the **Participant** must enforce safety rules in the premises, concerning:

- smoking ban
- the ban on bringing animals.
- the ban on bringing alcoholic drinks.
- the ban on entering the studios in street shoes and the obligation to be careful not to damage the dance floor.
